Overall Success: Since its establishment in late 2016 with a starting budget of approximately \$850.00 SRF has raised and distributed \$210,417.13 in member assistance to 211 dogs loved by 145 owners (some assisted more than one time) and 5 rescue groups thru 12-31-21.
